1. This Order may be cited as the

Short title.

REVENUE REPLACEMENT DUTY ORDER 2016.

2. (1) A duty shall be charged at the rate set out against the items listed in the Schedule to this Order, when imported into Belize from a non CARICOM country for consumption within Belize.

(2) In this paragraph, “non-CARICOM country” means a country that is not a Member State under the Caricom Treaty establishing the Caribbean Community.


3. The Revenue Replacement Duty Order and the Revenue Replacement Duty (Amendment) Order are hereby revoked.
